1 INTRODUCTION

1.1 COMPANY STRUCTURE

The company has two owner-Directors, and direct-hire administrative staff and core service consultants working in the head office. There is also a wider network of international consultants sub-contracted on a freelance basis for specialist services.

Secubiqe head office is in the Middle East, equidistant to all major international hubs, with affiliated companies and sub-consultants (for Engineering services and Training, respectively) in India and Europe (UK, France, Spain and Poland).
